# 2. Notes, decisions, issues, and comments

WP2: How to achieve R(AE)L INCLUSION: In-service Training Programme for Adult Educators

- partners agree that a common understanding of the WP2 topics outlined in the project proposal is necessary in order to ensure a coherent and cohesive approach to material development – DIP will provide a more detailed description of each topic, and partners will provide feedback
- partners agree to separate face-to-face (F2F) and online content so there is no major overlap between the two
- Deadlines:
  - o 7 December 2022 DIP will send a description of each topic
  - o **16 December 2022** partners provide feedback and vote on which topics will be developed for F2F or online learning
  - o 23 December 2022 Euni Partners will provide an outcome template
  - o **15 February 2023** DIP, Dante, and Euni Partners deliver the outcome framework
  - o **24 February 2023** all partners give feedback on the framework
  - o **28 February 2023** partners allocate tasks and agree on which partner is doing which subtopics and modules
  - o **30 April 2023** first draft of F2F and online content ready to be evaluated by stakeholders
- evaluation by 3 stakeholders per partner organisation done in May 2023
- translations to HR, BG, GR, FR, and SP done in the period June-September 2023
- the LTTA will be held in October 2023
- the pilot is scheduled for the period November 2023 January 2024

#### WP3: The Virtual Mirror Toolkit

- partners suggest that a portion of the e-Diary should not be automatically shared with the mentors, i.e. – there should be a section that is visible only to the users and a summary portion/reflective section that is shared with the mentor
- partners agree that guidelines on how to use/fill out the e-Diary should be developed and provided to users as an introductory step
- partners suggest to (in addition to other forums/discussion boards) introduce a space where users can share resources with others

WP4: Open-Source Online Platform for Self-Directed Learning and Networking of Adult Educators

- Zewelepe will provide partners with a report on what the virtual learning environment will look like and why it was selected
- a navigation session will be arranged to present the platform to the partners

## Project logo

- Zewelepe presented 10 logo suggestions, partners selected option 10 and provided feedback on how it should be improved (regarding the layout, spacing and colour of the elements)
- Zewelepe will send out a variation of option 10 for partners to give feedback on
- partners should upload their logos to Google Drive (to the WP5 folder)



#### WP5: Dissemination and Exploitation

- Facebook selected as the main social media channel for the project
- Euni Partners will provide a Facebook posting schedule each partner should post 4 times a month to the page

- edEUcation presented the Quality Assurance Plan all partners should provide at least 2 contact persons
- edEUcation will send out the evaluation form for the TPM

#### **Impact**

- based on the feedback provided by partners during the Impact+ exercise, DomSpain will revise the Impact Plan by end of November
- partners agree to include both quality and impact questions into 1 questionnaire for the target group so as to not inundate them with too many forms
