The "Tourism for Me – Accessible Tourism" platform has these main goals:

- Help people with disabilities find accessible tourist places or services in the Primorje-Gorski Kotar County and beyond.
- Encourage tourism workers to adapt their businesses for new types of guests,
 like tourists with disabilities.
- Promote tourism businesses that have made changes to support accessible tourism in Primorje-Gorski Kotar County and Croatia.
- Inform and motivate people with disabilities to enjoy accessible travel,
 vacations, and services, which is their right.

This platform was created as part of the "Tourism for Me" project.

The project ran from October 2023 to September 2024, funded by the Ministry of Tourism and Sports and other donors.

During the project, we trained people in tourism to work with guests who have disabilities.

We also informed the public about the rights of people with disabilities to have free time and travel.

Additionally, we trained people with disabilities to work in tourism and trained their mentors.

We created a tool for tourism businesses to assess themselves and receive recognition for their efforts to make tourism more accessible.

This recognition is called "Good Host for People with Disabilities."

The "Good Host for People with Disabilities" recognition is given to businesses that meet the requirements.

There are three levels:

- Meets basic requirements: training and signed statement about following the rules.
- Meets more than 50% of the requirements.
- Meets more than 80% of the requirements.
